ADVERTISEMENT FOR BIDS

Sealed Bids for 2019 Neighborhood Roads, Water, & Sewer, will be received by the City of Allegan, at the Allegan City Hall, at 112 Locust Street, Allegan, MI 49010 until 10:00 am, local time, on May 22nd, 2019, at which time they will be publicly opened and read.

In general, the work consists of improvements to two separate neighborhoods which will be divided into work as follows:

The Russell-Robinson Neighborhood Base Bid Work shall generally consist of the following:

Installation of new ductile iron water main to replace existing water main. Installation of new sanitary sewers and manholes, and removal of existing sanitary sewers and manholes. New pavement construction throughout the neighborhood including crush and shape in areas without underground infrastructure improvements.

Bid Alternate Number 1.1 shall generally consist of the following:

Replacing existing private water service lines from the right-of-way to the meter.

The Wolcott Neighborhood Base Bid Work shall generally consist of the following:

Installation of new ductile iron water main to replace existing water main. Installation of new sanitary sewers and manholes, and removal of existing sanitary sewers and manholes. New pavement construction throughout the neighborhood including crush and shape in areas without underground infrastructure improvements.

Bid Alternate Number 2.1 shall generally consist of the following:

Replacing existing private water service lines from the right-of-way to the meter.

Bidding Note: Contractors may submit bids on either the Russell-Robinson Neighborhood, the Wolcott Neighborhood, or both the Russell-Robinson and Wolcott Neighborhoods for consideration. Bids will be evaluated, and Contract(s) awarded based upon the best interests of the Owner.

A Pre-Bid meeting will be held at the Allegan City Hall, 112 Locust Street, Allegan, MI 49010 at 1:30 pm on Monday, May 13, 2019. All interested bidders are encouraged to attend.

Bids must be submitted on the forms bound herein, must contain the names of every person or company interested therein, and shall be accompanied by a Bid Bond in the amount of 5% of the amount bid with satisfactory corporate surety, subject to conditions provided in the Instructions to Bidders. The successful bidder will be required to furnish satisfactory Performance Bond and Maintenance and Guarantee Bond in the amount of 100% of the Bid, and Labor and Material Bond in the amount of 50% of the Bid.

Any Bid may be withdrawn prior to the scheduled closing time for receipt of Bids, but no bidder shall withdraw his Bid within 60 days after the actual opening thereof.

The Owner reserves the right to reject any or all Bids, waive irregularities in any Bid, and to accept any Bid which is deemed most favorable to the Owner.
