**3. Approval of Previous Meeting Minutes**

Motion to approve the minutes from February 10, 2021 by Peter, supported by Mark. Motion carried 6-0.

**5. Parks & Recreation**

- a. Allegan Mountain Bike Trail & Hiking Trail
  - i. Mel Brummel gave background and history on the formation of the Allegan Mountain Bike & Hiking Trail for the Public Spaces Commission and introduced plans to extend the trail from 3 miles to over 6 miles.
  - ii. Costs for extension, parking lot creation, and more is planned to be raised via crowdfunding.
- b. Other Comments
  - i. Joel and Doug made the group aware of the crumbling skate park located at Jaycee Park. The 15-year warranty on the project does not cover labor and repair costs exceed \$30K. As an immediate response, DPW staff will address the issues as they can to curb further deterioration.
  - ii. Mark brought attention to the cracking surface of the pickle ball courts located at Rossman Park.

  - ii. Joel informed the group that the area of overgrown shrubs, trees, and other ill-maintained foliage in Mahan Park along the boardwalk will be removed this summer. New plant life will replace what is removed.
- c. Other Comments
  - i. Rosie wants the City of Allegan to consider hiring an arborist for contract work.

- a. 2021 Downtown Flora Follow-Up
  - i. Board members were asked in January to provide their thoughts and ideas for downtown plantings in 2021. Korree was the only member to submit ideas after that meeting. His list was shared with the Doug and the DPW.
