SUBJECT: Discussion regarding DWSRF and CWSRF Project

### Action Requested:

It is requested that City Council review the DWSRF and CWSRF Project Plans in anticipation of the Public Hearing that will occur on May 24, 2021.

### Background:

Earlier this year City Council approved Abonmarche to develop a Drinking Water State Revolving Fund Plan and a Clean Water State Revolving Fund Plan. These plans identify the need to replace lead service lines citywide, and replace water and sewer mains in the Downtown, and in the Rossman Park (Marshall Street) Neighborhoods. These plans will be submitted to the State of Michigan and if approved by the State will result in a loan from the State of Michigan for these projects where a percentage of the loan will be forgiven.

SUBJECT: Review of May 4, 2021 Allegan City Elections

### Action Requested:

It is requested that City Council review and have a discussion regarding the May 4, 2021 Allegan City Elections.

### Background:

The Clerk along with Allegan City Election Inspectors conducted a fair and professional election on Tuesday, May 4, 2021. Recognition of the following Inspectors; Judy Jennings, Candace Grauman, Lyn Huff, Rebecca Rininger, Traci Perrigo, Sarah Perrigo, Christina Fulton and City Manager Joel Dye.

A total of 325 residents voted absentee with an additional 277 resident voting in person for a combine total of 602 ballots cast resulting in approximately a 16% voter turnout. The Allegan Public School Bond was approved by the voters in the district.
